At this time your information will be posted on the Club's bulletin board for the required thirty-day period. During this time, you will need to attend a minimum of 3 out of 5 events or activities listed below to help you get acquainted with the club and its members.

- Saturday Lunch or Dinner
- Thursday Night Dinner
- Volunteer with the Cooking Crew (for Thursday Night Dinner or a Ladies' Event)
- Member Orientation interview with Membership Chairman

# **Monthly Moorage Fees**

Moorage fees are based on the amount of water owned at .10 per square foot. (Example: 1200 sq. ft of water rights owned .10 x 1200 = \$120.00 per month). If the boathouse is hooked to sewer, there is a monthly charge of \$15.00.

Please note – at the time of water purchase a transfer fee is charged. The transfer fee is \$1.25 per square foot. (Example: 1200 sq. ft. X \$1.25 = \$1500 for the transfer fee to CRYC). This can be paid by either buyer or seller, as agreed upon by them.


